## REPORT FROM THE PRESIDENT OF THE ISH

These are exciting times for the ISH as we press forward our Agenda in Research and Education aiming also to be globally inclusive.

Since I last wrote in Hypertension News, the Executive Committee has agreed a number of initiatives and I am



pleased to report progress on some of these.

### 1. ISH Research Foundation

**Dr John Hall** has been leading on this and I am delighted to report that in January the Executive Committee agreed his outlines for terms of reference for our Research Foundation.

The programme will support the training of postdoctoral sciences from Middle and Low Income countries in the formative stages of their careers so that they can conduct clinical, epidemiology/population science or outcomes research and will provide individuals with a period of mentored research as part of a collaboration between the scholar and the sponsor at an established research institution.

Further news and details of the scheme will be published on our website very shortly and an advertisement will appear in the May issue of the Journal of Hypertension. The deadline for applications is 1<sup>st</sup> November 2009.

Needless to say the Society is extremely excited about beginning to fulfil its mission to support research into hypertension worldwide.

### 2. Membership

Dr Rhian Touyz has been leading on this and I am delighted to report that membership of our Society has reached nearly 800 from across the globe and representing all



regions. This means that we have a closely knit community which can be accessed electronically in terms of providing collaborative links and communications from an educational and research perspective.

Professor Stephen Harrap and Professor John Chalmers have taken our membership further in terms of establishing an International Forum which now boasts 74 countries and this again means that we can reach out across the world in terms of exchanging information and intelligence both about the clinical management of hypertension as well as researching this complex disorder.

### 3. Education

Our teaching activities are extending further across the world. Professor Robert Fagard who is the Chair of our Educational Programmes has scheduled further meetings in sub-Saharan Africa in the next two years and in addition in 2009 the ISH will be sending Teaching



Faculties to ten countries around the world to educate in terms of hypertension management and best practice and the implementation of guidelines. Countries include: Taiwan, China, Venezuela, Mexico, Guatemala, Chile, Argentina, Brazil, Peru and Korea.

### 4. Call to Action

There is a very real need to highlight the impending epidemic of cardiovascular disease which will engulf Middle and Low Income countries in the next two decades unless action is urgently taken.

I am delighted to report that in collaboration with the WHO and The Lancet, the ISH will hold a Summit in 2009 to address this issue during the activities around the September Vancouver 2010 ISH Meeting.

To this we shall invite politicians and healthcare professionals that influence policy within a variety of Middle and Low Income countries to come together to develop a consensus document which will hopefully shape the way that preventing cardiovascular disease from taking a hold in such countries is implemented.

Finally, these are exciting times for the ISH and as I have intimated above we wish to be an inclusive Society.

## Join us in Vancouver, Canada for ISH 2010

The 23rd Scientific Meeting (ISH 2010) to be held from 26<sup>th</sup> - 30<sup>th</sup> September 2010 in beautiful Vancouver, Canada promises to be an exciting and rewarding event.

The theme of the 2010 Meeting is **Global Cardiovascular Risk Reduction.** The meeting will deal with the newest information in the field of hypertension and will also focus on the other major risk factors for cardiovascular disease. Future perspectives, new research, treatment and prevention will be showcased through the Scientific Program covering four days of invited plenary talks and oral and poster presentations. Keynote speakers will include pioneers and leading investigators in the fields of cardiovascular, renal, and metabolic health.

The Meeting will also include Industry and Investigator-initiated Symposia held before and after the Scientific Program at various locations in Vancouver and across Canada.

Three major tracts will be:

- Basic Science
- Clinical
- Population Health / Public Policy

The target audience includes basic scientists, clinicians, nurses, dieticians, population health and public policy specialists as well as all individuals interested in cardiovascular health.

The objectives of the meeting are to provide the most up to date information from leading experts around the world. The meeting will feature small group ('How to') sessions within each theme including new techniques and methods in basic research, patient assessment and management as well as assessing and implementing population health and health policy. Translation scientific sessions will provide a learning opportunity for new concepts in hypertension, obesity, diabetes mellitus, lipid disorders, cardiac arrhythmias (atrial fibrillation), heart failure, renal disease, stroke and other conditions to be translated from the sphere of basic science to clinical medicine and to population health/public policy.



The meeting will provide a forum for scientific exchange, global interaction and global initiatives with the objective of a legacy of new initiatives in Global Cardiovascular Risk Reduction.

With support from the Canadian Hypertension Society, Asia Pacific Society of Hypertension, Inter-American Society of Hypertension, the World Hypertension League and the Chinese Hypertension league, and a growing number of other affiliated Societies, we believe ISH 2010 will attract a large number of participants from around the globe making it the major meeting on hypertension and other cardiovascular risk factors in 2010.

### **ABSTRACTS**

ISH 2010 will begin accepting abstracts in June 2009.

Early decisions on acceptance of abstracts will give participants a longer lead time for visa applications. Late breaking novel basic science and clinical trials will showcase important new research.

reasonably priced alternatives;


many with views of the mountains and ocean. Online hotel reservations will be available in fall 2009.

The mission of the American Heart Association's Council for High Blood Pressure Research (CHBPR) is "to foster excellence in high blood pressure research and education" and achieve the Association's objectives in the field of hypertension. Members support the Association's mission of "building healthier lives, free of cardiovascular diseases and stroke."

The Council is dedicated to promote the study, prevention and cure of hypertension and associated disorders by sponsoring an internationally renowned annual scientific conference and the Hypertension journal. Its activities are designed to encourage research and disseminate information. Its programs encourage scholarly research by both junior and senior investigators and its sponsored awards recognize excellence in the field of hypertension.

It is a Council of the American Heart Association with over 2,000 fellows who are basic scientists, physician scientists and practicing clinicians. The Council's annual international scientific conference presents state of the art basic and clinical hypertension research.



The fall conference presentations are published in the American Heart Association's journal, *Hypertension*. The Novartis Award for Hypertension Research, the most prestigious award in this field, is also presented at the conference, as are multiple other awards recognizing the outstanding Council members. Associated with the conference is a workshop designed to disseminate a focused scholarly update on a particular topic of interest to the Council members.

### SINGAPORE HEART FOUNDATION



The Singapore

Heart Foundation (SHF), formerly known as the Singapore National Heart Association (SNHA), is a non-profit charitable organisation at the forefront of the battle against heart disease in Singapore. Since its inception in 1970, the Foundation has grown into a well-established and reputable organisation with local and international links.

With increased support from the public, the SHF continues to work towards its vision of becoming a leading heart health movement in the region and a household name in Singapore through educating and motivating the public, assisting those affected and supporting community-based research to better understand the landscape of heart disease in Singapore.

The SHF has funded research projects aimed at reducing disability and death from heart disease through understanding its nature and causes, as well as implementing effective public education and prevention programmes in the community.

Since 1999, the SHF has funded 30 clinical research projects. To date, some of the findings of these studies have been shared in 20 conferences and published in 4 journals.

Apart from assisting clinical research, SHF has also supported community-based research, such as the annual Heart Health Awareness Survey and the 2006 Go Red For Women Survey. The SHF has also initiated Action Research opportunities with schools through the following:

School Traffic Light System - the impact of coding food in the school canteen on the consumption of fruit and vegetables

Health Mapping Exercise - profiling the health status of residents living in rental flats and investigating service learning of students

Jump Rope for Heart - the relationship between skipping and childrens' gross motor skills

Family and Friends CPR Anytime Kit (a community pilot project) - the influence of a home CPR kit on skills application and attitudes towards learning and performing CPR

### SINGAPORE HYPERTENSION SOCIETY

The Singapore Hypertension Society (SHS) was formally inaugurated on 23 February 2002 by a group of physicians from various disciplines.

The founding President of the SHS was Dr Low Lip Ping. The mission of the Society is to promote awareness, prevention and optimal management of hypertension by public education, continuous medical education and research in hypertension. SHS works closely with other national societies in promoting a healthy lifestyle in the population.

The SHS is active in organizing hypertension-related scientific meetings and seminars regularly to advance the practice of hypertension management.

The Society is affiliated to the Asian Pacific Society of Hypertension and held the 3<sup>rd</sup> Asian Pacific Congress of Hypertension on 3 April 2004 with the support of the Singapore Heart Foundation, the Singapore Cardiac Society and the Singapore Society of Nephrology.

It also advocates research and publication of medical and scientific works on hypertension as well as promoting regional and international co-operation in the study of hypertension. It has held 2 annual scientific meetings. The SHS has also published two editions of National Guidelines on the Management of Hypertension.

# POLISH SOCIETY OF HYPERTENSION

The Polish Society of Hypertension (PSH) was founded in 1987 within the Polish Society of Cardiology. The main initiative came from three centres (Warsaw, Cracow, Gdańsk) which for decades have conducted extensive studies of epidemiology, pathology, complications and management of arterial hypertension.

The aims of the Society are research, education and development of guidelines to improve effective control of hypertension in Poland. In 1987 the PSH became a member of the World Hypertension League and ESH. From the initial 47 members, the Society's membership has grown to more than 1,000, not only physicians, but also other health professionals and scientists with an interest in hypertension.

The first Scientific Meeting of the PSH took place in 1989 and since then the meetings are organized every two years, and include a general assembly of the members and election of a new President and Board of the Society. Moreover, in collaboration with other Polish scientific societies, the PSH organizes sessions concerning hypertension during their meetings. Between 1995 and 2006 the PSH arranged seven satellite symposia of the ESH Scientific Meetings.

The official journal 'Arterial Hypertension' has been published bimonthly since 1997 and in collaboration with the Society's Board, an annual educational conference is organised.

The PSH website (www.nadcisnienietetnicze.pl) provides information about ongoing and planned activities for members and educational information for patients. Forty three members of the PSH are the ESH Specialists in Clinical Hypertension. The medical subspecialty of hypertension was established in 2003. There are 16 centers accredited to supervise the process of specialization with 100 posts in total.

The Society maintains registries of essential and secondary hypertension in Poland, organizes postgraduate courses for physicians and many educational activities for patients. The members take an active part in publicizing the problem of hypertension in national radio and television programs.





### World Hypertension League (WHL)

World Hypertension League (WHL) was established on January 4, 1984 and currently has 83 national member organizations. Regular membership is granted to only one national origination per country. Individual membership is not possible. The WHL covers a population of more than three billion people worldwide.

The objective of the WHL is to promote the detection, control and prevention of arterial hypertension in populations. The WHL is a federation of leagues, societies, and other national bodies devoted to the above objective. The thrust of the WHL's action is in liaison with the member organizations, promoting the exchange of information among them, and offering internationally applicable methods and programs for hypertension control. Bringing together and stimulating organizations committed to the control of hypertension is the goal and *raison d'etre* of the WHL.

The WHL is a division of the International Society of Hypertension (ISH) and is in contact with other major hypertension societies and it enjoys an official relationship with the World Health Organization (WHO).

A major activity of WHL is World Hypertension Day celebrated on May 17<sup>th</sup> every year in all member countries around the world. Other activities include the WHL International Art Competition, Patient Education Project and a Newsletter that is distributed six times/year in multiple languages to nearly 50,000 people worldwide.

The current President of WHL is **Professor Liu Lisheng**, from Beijing, People's Republic of China and the Secretary General is **Professor Arun Chockalingam** from Simon Fraser University, Vancouver, Canada.

### CONFERENCE REPORT

7<sup>th</sup> Meeting of the **Asian-Pacific Society** of Hypertension

19<sup>th</sup> - 22<sup>nd</sup> February 2009 Kuala Lumpur, Malaysia

The first meeting of APSH was held 10 years ago in Indonesia and the Society has expanded and developed in strength since that time. This 7<sup>th</sup> meeting was held in Malaysia and was attended by over 1,300 registrants and more than 50% were from outside Malaysia. The attendees were welcomed by the Malaysian Minister of Health, followed by an interesting cultural display and reception.



The scientific meeting occupied three days and was a blend of Plenary lectures, Symposia and Free Communications. There were a number of speakers from Europe and the Americas but increasingly the majority of speakers are coming from the Asian Pacific region.

Professor Yutka Imai from Japan gave the first invited Lectureship of the Society which on this occasion was to honour Professor Arakawa and Professor Johnston who were founding Trustees of the Society and without whose guidance the Society would not have prospered.

Professor Bryan Williams from the UK and Professor Thomas Unger from Germany were initially invited to give other talks, but as they were present, an interesting debate was held related to the topic that ACE Inhibitors have effects over and above blood

pressure control. There was general agreement that other effects of ACEI and ARBs can be demonstrated but the evidence that these translate into clinical effects is far from convincing.

The plenary lectures were on a variety of topics and covered many aspects of hypertension. A major



symposium was on the importance of Sleep Blood Pressure which was appropriate as much of the evidence for this has come from this region.

In addition to the scientific program excellently organized under the guidance of Kalid Yusoff, there were a number of Luncheon Symposia supported by the Pharmaceutical Industry which presented new data on a number of clinical trials to which this region now makes major contributions.

The Malaysian Hypertension Society drafted The Kuala Lumpur Declaration which was supported by the Trustees and the Meeting and calls for Action by



doctors, governments and the community to reduce the incidence of hypertension, to detect hypertension and to ensure that appropriate treatment is made available at an affordable cost. During the meeting some of the ways that these goals can be met were discussed. However the Declaration needs to be endorsed and taken to the individual Governments by the Member Societies.

The 7<sup>th</sup> Meeting of the Asian Pacific Society was a great success and the 8<sup>th</sup> meeting will be held in Taipei, Taiwan in November 2011. This meeting promises to continue the success of the previous meeting and we extend an invitation for doctors from

Europe, The Americas and Africa to attend. **Trefor Morgan**
